#### Projects completed by design studios led by Ray Huff:

### 1600 Meeting Street, Charleston, 2012

Development of a new creative workspace community was designed by the studio as an anchorin the emerging Creative Corridor in Charleston envisioning campus that articulated a new vision for this type of workplace.

## Public Realm Study, Charleston, 2011

The Medical University contracted with Studio U to examine the public space that makes up the University and to develop a planning framework for creating an arboretum district on the campus.

### Reconceptualizing the Library, Charleston, 2010

The Medical University of South Carolina requested Studio U led by Huff to rethink the university's academic library in light of new means of accessing digital information. The studio's study was extensive and resulted in a greatly expanded program to engage the campus as an urban condition and to reset the library as a campus locus.

### Town of Awendaw, Awendaw, 2010

The Town of Awendaw is a small diverse community on the coast north of Charleston. The town had been embroiled in a controversy about development in the town proper. In this context, the students conducted a series of town planning proposals that articulated a clear vision for the community that was favorably received by all parties.

### Project Okurase, Accra, 2009

An international NGO based in Charleston approached the CAC.C to design a 16-building complex in rural Ghana. The studio was charged with designing the project and producing working drawings for eventual construction of the proposed design. Several students visited Ghana during the development of the project. The project is currently under construction.

### Intermodal Center, North Charleston, 2009

The City of North Charleston and CARTA (regional transportation authority) approached the CAC.C about designing an urban center for a proposed intermodal transportation facility. The studio developed a sophisticated urban plan that integrated the new facility with mixed use development including residential uses that was widely praised by the City and CARTA.

## Global Climate Study, 2008 (NCARB Prize)

The CAC.C prepared detailed analysis of peninsula Charleston and the impact global warming could have on the historic city with water level rises of 1, 3, 6 and 12 meters. The strong graphic presentation was compelling and provided clear visual evidence of potential impact on the historic city.

### Orphan Aid Society, North Charleston, 2005

The former Jenkins Orphanage, now known as the Orphan Aid Society, is located on 40-acres of coastal property along the Ashley River. The studio prepared detailed development plans for the redevelopment of the property with the intent of creating a sustainable revenue stream while continuing their mission to house orphaned children.

## Evening Post Publishing Company, Charleston, 2005

The first service learning project for a private client, the studio conducted a study of 13-acre of prime downtown property owned by the media conglomerate. The studio was instrumental in influencing the design strategy for this property that is at the gateway to the downtown core area.

### Market Street Study, 2004

The studio prepared an urban plan for the redevelopment of the Market area in downtown Charleston.

## Upper Concord Neighborhood, Charleston, 2003 (NCARB Prize)

A vertical studio project of the Clemson Architecture Center in Charleston (CAC.C) that involved urban design of an 8-acre site vacate site in downtown Charleston. The project culminated in a city wide design charrette led by the students that saw several hundred citizens participate in the process. The design is being implemented today by the City of Charleston.

## Center for Civil and Human Rights, Atlanta, Georgia, 2009

An international design competition by invitation was conducted to design the new Center for Civil and Human Rights adjacent to the World of Coca Cola in Atlanta. The project is intended to commemorate the Civil Rights Movement and Human Rights in the US and abroad. The firm's design was recognized as an innovative approach to a very challenging site and program of significant cultural and social significance.

## Architecture for Humanity Biloxi Housing, Biloxi, Mississippi, 2006, (1st PLACE)

The firm was selected in a design competition to design a replacement house for a family who lost their home to Hurricane Katrina.

## Virginia Key Beach Park Museum, Miami, Florida, 2005 (1st PLACE)

This national design competition was won by the firm for the design of a \$32M legacy museum to celebrate the former "Negro Only" beach in Miami. The design envisioned a building intertwined with the landscape as the story of this hallowed place is embedded in the landscape.

## Lobby Pavilion at the John F. Kennedy Federal Building, Boston, Massachusetts, 2004 (1st PLACE)

GSA invited four firms to design a new security pavilion in response to 9/11 as and addition to the historic JFK Federal Building. This building was the project designed by Walter Gropius in concert with The Architects' Collaborative (TAC). The design had to respect this important International Style building while meeting stringent US Marshal security requirements. The design celebrated the achievements of President Kennedy while employing state-of-the-art security.

## Motown Center Competition, Detroit, Michigan, 2003 (Invited)

Huff+Gooden Architects were invited to participate in the design of this hybrid facility to celebrate and commemorate the legacy of Motown Music in Detroit. The design established a clear urban strategy that would be instrumental in the redevelopment of the urban fabric of Woodward Avenue, a key artery in this troubled US city. Other participants included Machado Silvetti of Boston, Mark Rios of Los Angeles, and ARO of New York.

## Brooklyn Visual and Performing Arts Library Competition, Brooklyn, New York, 2002 (Invited)

One of four international firms invited to participate in the design of a ground breaking library, the new facility was a 200,000 square foot, eight level library along an important urban corridor in Brooklyn. The design envisioned a "vertical stage", an all-glass facade to activate the street and to make transparent the library as a still relevant civic institution. The four invited firms included Jean Nouvel of France, Enrique Norten of Mexico, Rafael Vinoly of New York, and Huff+Gooden of Charleston.

## Queens Museum of Art Open Design Competition, 1999

The first design competition of the firm, the Queens Museum of Art (QMA) was to renovate the historic pavilion built as part of the 1939 New York World's Fair. The design determine it as essential the museum embrace the site and become an institution of inclusion. The design process was extensive involves literally hundreds of studies. The final design was exhibited at the Urban Center in New York.
