## **Major Fields of Interest**

**Urban Design, Urban Form, Meaning in the Built Environment** – These interests include conventional approaches to form giving in addition to aspects of regional character that are reflected in natural, historical, and cultural features. Pertinent to these interests are characteristics and means of shared understanding as they relate to sustainability, community, aesthetics, and ethos within given cultures for purposes of attaining meaningful cultural, built, and natural environments.

**Community Based Service Learning** - Included in this interest basic and applied research efforts providing graduate students with "real world" planning experiences that simultaneously engage and assist client communities, community groups, and elected and appointed officials in visioning, community development, land use issues, implementation, and funding strategies.

### Dissertation

Title: "Cultural Ethic and the Urban Landscape: a Basis for Sustained Community"

This study presents and analyzes historical data pertaining to the scientific revolution, the Age of Enlightenment, Romanticism, landscape architectural theory and urban form as a partial basis for developing a "cultural ethic" practicable by the environmental design disciplines. A humanistic concept of regionalism and substantive practices are shown to be integral components of the ethic. Regard for regionalism and region-based tradition is concluded to be fundamental to the realization of "place" and the attainment of meaningful built environments.

Title: "Santa Barbara Municipal Airport, Master Planting Plan Guidelines and Recommendations" Conducted under contract to the City of Santa Barbara, this project developed planning and land use recommendations for the City's municipal airport. Located on fill within a major portion of a salt-marsh habitat, the 944 acre project site provided opportunities and constraints arising form airport use and maintenance; saline soils; abundant ground water; major remnants of a WW II U.S. Marine air base; archaeological sites; significant local and regional native vegetation; and proximity to the Pacific Ocean, and confluence of ten intermittent streams draining a topographically diverse 30,000 acre watershed.

## **Program Development Activities**

In addition, discussions were held with leading professionals in the field of landscape architecture, offices were visited to observe working environments and a presentation was held at U.C. Berkeley's Environmental Simulation Lab.

## Seminar in Park Administration and Landscape Architecture

This seminar was organized to introduce senior level students at Texas Tech University to advanced aspects of design processes and regional factors affecting such processes. Particular attention was given to ways of thinking, seeing and visualization, and cultural considerations affecting and affected by the human condition.

## PLAN 261: Communication and Presentation Techniques

PLAN 261 was a new course in Ball State University's Department of Urban Planning, which I organized and developed. This course prepared students in the use of 35mm SLR cameras, automated slide presentations with multiple sound tracks, video presentations with multiple sound tracks, desk top publishing, image manipulation with computers, teleconferencing, the "information super highway," oral presentations, and diagrammatic drawing.
